I write to give my strongest recommendation to our student planning organization, the Organization of Cornell Planners, for a best practice award.

OCP envisioned, organized, sponsored, raised funding for two innovative and striking educational and practical planning events this Fall: An Active Transportation Symposium (also an impressive collaboration with local organizations, county officials and legislators, and another college) and a multi-faceted Regional Planning Symposium too.

Both brought first class speakers, deeply knowledgeable about cutting-edge cases. The Regional Planning events focused on the Portland Housing Bureau's efforts, those along New York's Hudson River Corridor and current work in Chicago, for example. The Active Transportation Symposium not only brought Jennifer Dill but Mia Birk whose efforts to bring innovative bicycle planning to U.S. cities will be nothing less than historic (her firm has grown from a staff of four to one hundred, and she speaks powerfully to an idea whose time has come).

The Active Transportation Symposium brought to our campus city and county and state officials now sitting in the same room with local activists, educators from a network of local schools, undergrads, masters and doctoral students along with our faculty as well. The ideas discussed will change not only some of our department's coursework, but some of our city and county's efforts to improve our local transportation planning as well. So this was no mere symposium: it was convening stakeholders, advancing practical agendas, supporting efforts for change by networking in half a dozen ways, giving practical planning a shot in the arm, to say nothing of its obviously excellent educational benefits. But not only that, the discussions of symposium participants continued at a very well attended meeting on a Saturday morning in the County Public Library where attendees discussed and organized support for a set of practical initiatives.

So OCP has done a terrific job, educationally, professionally, politically: truly an example of Best Practice!
